1. This license is valid only for the dates indicated above. Property with an annual license may be left on the Dunedin Causeway for no more than two nights in any seven day period.
2. All personal property will be stored / parked in a manner that does not limit access of the general public to the waters edge and will be stored safely and neatly. Do not leave boats, trailers, vehicles or other property on the shoreline.
3. A license sticker must remain on the item of personal property being left on the Dunedin Causeway at all times and in a manner that may be viewed by Law Enforcement Officers or City Employees.
4. Property left longer than licensed hereunder may be towed at owner's expense and this license will be revoked.
5. No overnight camping or other personal occupancy of the Causeway is permitted hereunder.
6. This license may be revoked with or without cause by the City Manager or City Employees under his direction or by a Law Enforcement Officer.
7. Any use of this license by an individual not entitled to its use will subject this license to immediate revocation. This license is not transferrable or assignable and may be used only by the licensee.
8. This Revocable License does not create a property right in the licensee.
9. By application for and acceptance of this License, the licensee waives all claims against the City or Law Enforcement personnel for any loss of, damage to, theft of or any and all other loss or damage to the said property and does hereby, in consideration of this license indemnify and save the City harmless from any liability of any kind arising from storage of such personal property on the Dunedin Causeway.
10. Forty (40%) percent of the cost of the Annual License is attributable to the cost of administration, record keeping and other administrative costs. Sixty (60%) percent of the Annual License fee is for enforcement, inspections and similar activities. In the event that this license is revoked without cause, a pro rata portion of the enforcement portion of the license fee will be prorated and refunded.

I have been informed of and I understand the conditions of the issuance of this Revocable License. I have carefully read the terms of this Revocable License and I accept and agree to abide by its terms and conditions.
