Per the City Charter, Section 5.03 The Mayor and Commissioners for Seats 1 & 3 WILL SERVE A FOUR (4) YEAR TERM, commencing the second (2nd) Monday following the election (November 21, 2016).

Pursuant to the Dunedin City Charter, Section 5.01, Elections, "Requires a person to be a registered voter and resident of the City of Dunedin, Florida for at least one year immediately prior to qualifying and submitting petition cards.

Further, pursuant to the Dunedin City Code, Sec. 26-73, Method of qualifying, "As a condition precedent to qualifying, the candidates shall be required to file with their petition cards personal affidavits showing that they are residents of the city, having physically resided therein for a period of at least one year immediately prior to submitting the petition cards and are qualified electors of the City."

MUNICIPAL ELECTION

To vote, you must be registered by October 10, 2016. **HOWEVER**, if you are a **NEW RESIDENT** in the City of Dunedin, **BUT ARE A REGISTERED VOTER IN ANOTHER MUNICIPALITY WITHIN PINELLAS COUNTY**, you will still be eligible to vote in the November 8, 2016, election by filing your new address, with proof, at your polling location.

ALL Dunedin Elected Officials are elected at large, which means:
All registered voters within the corporate limits of the City of Dunedin, are eligible to vote for the Mayor, the Commissioner for Seat 1 and the Commissioner for Seat 3.

For Your Information: Both photo and signature identification will be required at the polling place for all elections.
