# **BY THE NUMBERS**





In 1964, the City of Dunedin invited the Town Council of Stirling, Scotland to enter into a Sister City relationship in order to share in an exchange of ideas, cultural achievements, correspondence, club affiliations and visitors, creating good will between the two communities. This invitation was motivated by the fact that the City of Dunedin was originally settled by Scottish families, a heritage which has been continuously honored through the use of Scottish bagpipes, band uniforms and street names, among other things.

The City began the formalization of the Sister Cities program procedures in November of 2019. What records exist from 1964-2019 have been compiled here. Every attempt has been made to create a comprehensive documentation of visits, gifts, etc., but the records are in no way complete. Going forward, this document will be kept up to date and current.

From the Sister Cities International Website:

A sister city...is a broad-based, long-term partnership between two communities in two countries. A relationship is officially recognized after the highest elected or appointed official from both communities sign off on an agreement to become sister cities.

A city may have any number of sister cities, with community involvement ranging from a half dozen to hundreds of volunteers. In addition to volunteers, sister city organizations can include representatives from nonprofits, municipal governments, the private sector, and other civic organizations.

Each sister city organization is independent and pursues the activities and thematic areas that are important to them and their community including municipal, business, trade, educational, and cultural exchanges and projects with their sister city.

Sister Cities International was created at President Eisenhower's 1956 White House conference on citizen diplomacy. Eisenhower envisioned an organization that could be the hub of peace and prosperity by creating bonds between people from different cities around the world. By forming these relationships, President Eisenhower reasoned that people of different cultures could celebrate and appreciate their differences and build partnerships that would lessen the chance of new conflicts.

Sister Cities International Mission: To promote peace through mutual respect, understanding, and cooperation — one individual, one community at a time.



# HISTORY

Stirling, Scotland became the City of Dunedin's first Sister City on June 15, 1964 by Resolution 975 (through the People to People program).

Summerside, Prince Edward Island, Canada became the City of Dunedin's second Sister City on April 20, 2000 by Resolution 00-19.

We now maintain both relationships through the Sister Cities International program and pay annual dues to that end.

# Stirling, Scotland

Stirling, situated in Stirlingshire council, has a little over 45,000 inhabitants. The main feature of Stirling, and main tourist destination, is Stirling Castle, clearly visible from miles around the city. Stirling was created a Royal burgh by King David I in 1130 until 1975 when the burgh was abolished. As part of Queen Elizabeth II's Golden Jubilee in 2002, Stirling was granted city status. However, in earlier times Stirling was the capital of Scotland and it was also important as the "Gateway to the Highlands", with its position near the Highland Boundary Fault between the Scottish Lowlands and the Highlands.

Stirling is the administrative center for the Stirling Council area and is traditionally the county town of Stirlingshire. Stirling is a center for local government, higher education, retail, and industry. The 2011 census recorded the population of the city as 45,750, while the wider Stirling council area has a population of roughly 90,000. The majority of the population is located in its southeast corner, in the City of Stirling and in the surrounding area.



# Summerside, Prince Edward Island (PEI), Canada

Summerside is a Canadian city in Prince County, Prince Edward Island. It is the second largest city in the province and the primary service center for the western part of the island. Summerside was officially incorporated as a town on April 1, 1877. Summerside is named for an inn owned by George Linkletter II, called Summer Side House. The population of the Town of Summerside at the time of the 2016 Census city was 14,829.

Summerside boasts The College of Piping and Celtic Performing Arts, where 45% of people have their origins in Scotland. The Island has been described as the most Celtic of all states and provinces in North America because of this tide of immigration. In the late 1770s, Scottish settlers landed on the beaches of Prince Edward Island looking for a better life and more opportunities for their children.

The Summerside City Council is governed by a mayor and eight councilors who represent geographic areas called wards.



# **OVERVIEW OF SISTER CITY VISITS**

# Stirling schedule of visits

Visits will ideally take place every two years, in a staggered manner. For instance, in 2021, the Stirling Provost is scheduled to visit Dunedin. In 2023, the City of Dunedin should visit Stirling, followed by a visit from their Provost in 2025, so that every four years, a City delegation makes a trip. The Stirling delegation visits during Dunedin's Highland Games (April). The City of Dunedin should try and schedule their trip to coincide with either Dunedin's Pipe Band participation in the World Pipe Band Championships, or the Stirling Highland Games, if possible.

# Budget

The City currently budgets \$5,600 annually for three years in a row, then \$10,500 in the fourth year (to include travel) towards the Sister City program. This pays for:

Annual dues

Provost's hotel for one week on their visit to Dunedin (work to partner with local hotels that may help sponsor), and possible Mayor dinner Travel during odd years

Promotional/welcome materials

**Dignitary Gifts** 

Welcome gifts for visiting Stirling citizens/tourists

Student exchange

Every four years, when a Dunedin delegation makes a trip to Scotland, there is an additional budgeted amount for City visits to Stirling to cover the airfare and food for the Mayor or representative while on official visit, as well as airfare, food and lodging for additional Dunedin staff and/or officials. Stirling pays for five hotel nights for one Dunedin representative (typically the Mayor or a Commissioner).

# PROTOCOL FOR SISTER CITY VISITIING DIGNITARIES

**BEGINNING IN 2020** - Protocol for visits from the Stirling Provost to Dunedin:

The City of Dunedin pays for one hotel room for one week (Sunday check -in; Sunday check-out).

# **Formal Schedule**

Sunday – Arrive

Monday – Reception (DFAC), exchanging of gifts Tuesday – Dinner (SAS)

Wednesday – Whisky tasting (NWC)

Thursday – Off (possible dinner with the Mayor; or if a Commission week, present the Dunedin flag to the Provost at the Commission meeting) Friday – Parade and Ceilidh (DSAF)

Saturday – Highland Games (DSAF) – Provost is Chieftain of the Games Sunday – Depart

To consider:

- Kirking of the Tartans (Several churches do this, including First Presbyterian, Church of the Good Shepherd and Our Lady of Lourdes)
- Tartan Day at the Stadium

# Sight-Seeing Schedule

Find out in advance what they would like to do during their days, so that we can arrange. Some ideas (Accompanied by City staff or one of our organization members? Transportation provided? Paul Stanek via golf cart?):

- Dunedin Golf Course
- City Departments (Library, Planning & Development, etc)
- Tarpon Springs, Sponge Docks
- Ferry to Clearwater Beach
- Dunedin History Museum
- Chamber/DDMA visit
- Honeymoon Island
- High School Band (band practice Wednesday and Thursday nights)
- Dunedin Fine Art Center
- Highlander Park to see Highland Games preparation
- "Scottish Tour" (historic landmarks, SAF, SAS, 'Celtic' businesses)

# **Invitation Procedure**

Send the invitation the summer before their visit (i.e. send in the summer of 2020 for a spring 2021 visit). This should be a joint invitation from the City, Scottish Arts Foundation, the Scottish American Society and the New World Celts. Begin preparing at that same time, so that their information gets into the Highland Games program book, etc. There should be an agenda welcoming the Stirling delegation onstage at the Highland Games, as the Chieftain of the Games. They should be on stage for the closing ceremony at 5pm as well.



# PROTOCOL FOR VISITS TO SISTER CITY

Every four years, a delegation from the City of Dunedin will ideally make a trip to Stirling, Scotland. This would be 2023, 2027, 2031, and so on. The delegation would be made up of the Mayor (or representative), staff, and interested Chamber/community members.

For visiting years, there should be an addition to the budget to account for travel expenses. We currently have budgeted \$5,600 for off years; travel years are \$10,500. This should be added to the budget the previous year; for instance, for the 2023 trip to Scotland, \$10,500 (assuming two travelers) should be put into the FY 2023 budget in February 2022.


The City of Dunedin delegation should bring gifts for the Provost.

Typically Dunedin trips to Scotland take place during the summer months of July and August. If possible, these should be scheduled to coincide with Dunedin's Pipe Band participation in the World Pipe Band Championships, and/or the Stirling Highland Games.

Upon return, the program manager should hold a debriefing with travelers regarding:

- Exchange of gifts
- Lessons learned
- Suggestions
- Miscellaneous information
- Next steps




# TRADE DELEGATION

# **Arts & Culture Advisory Committee**

The Arts & Culture Advisory Committee is a volunteer committee of Dunedin Residents, created to advance the cultural identity of the City and to enhance and facilitate the scheduling and planning of public projects of an art and cultural nature.

# **Downtown Dunedin Merchants Association**

The Downtown Dunedin Merchants Association (DDMA) is a non-profit organization that was developed to promote awareness of the local merchants in the business community. They do this by organizing and implementing downtown events, advertising through local publications and online media outlets, and networking with like-minded business organizations.

# **Dunedin Chamber of Commerce**

The Dunedin Chamber of Commerce, established in 1926, is a vibrant, active organization with a diverse range of benefits and services, both for its members and the community. The Chamber is committed to ensuring businesses survive and thrive, and offers services like networking opportunities, tourism promotion and services, education, and marketing opportunities. The Chamber partners with many other organizations in the community to help ensure the area continues to grow in the best manner possible for residents and visitors.

# **Dunedin Fine Art Center**

The original idea for an art center in Dunedin dates back to 1969. When the doors to the first 2000 square foot facility were opened in February of 1975, a commitment to excellence and a welcoming spirit were the guiding lights that you can still see in DFAC's nearly 50,000 square feet of facilities. Today, the Dunedin Fine Art Center (DFAC) is built on strong foundations within the community. Through donations, endowment and memberships, the center is able to exist and expand to serve the community and meet the needs of our society.



# **Dunedin History Museum**

The 501(c)(3) Dunedin History Museum contains approximately 2,000 artifacts, 2,500 photographs, and a library containing 200 volumes of local and Florida history. Included in the collection is an electronic archive of the Dunedin Times Newspaper, from 1924 through 1965. Permanent exhibit segments feature statewide topics such as the railroad and citrus industries. Regional topics include Dunedin's multicultural origins, our pioneering families, Mease Hospital, sports history of Dunedin, industries in Dunedin, development of the alligator tank used by the U.S. Marines during WWII in the Pacific, and natural habitats such as Caladesi and Honeymoon Isle.

# **Dunedin New World Celts**

The Dunedin New World Celts (NWC) was founded in 2002, and has grown more than 20 fold from the Original 10 founding members and today's Dunedin Chapter of the New World Celts can be found supporting festivals, community events and sponsoring heritage celebrations all around the greater Tampa Bay area and Southeastern United States.

# **Dunedin Scottish Arts Foundation**

Formerly the Dunedin Highland Games & Festival Committee, the group was renamed the Dunedin Scottish Arts Foundation (DSAF) in July 2015. The DSAF are a group of volunteers and supporters, dedicated to preserving and promoting the Scottish culture of the City of Dunedin. Dunedin was founded in 1899 by Scotsmen, and our heritage runs deep.

# Scottish American Society of Dunedin

The Scottish American Society of Dunedin (SAS) was founded in 1980, to celebrate and carry on the Scottish traditions in Dunedin, FL. The mission of the Society is to preserve, teach and honor the culture, traditions and history of Scotland through performing arts programs, activities, special events and charitable gifts to deserving individuals and youth organizations in Dunedin. The Scottish American Society of Dunedin is a 501 (C) (3) Organization and offers scholarships to the youth of Dunedin to help them study the Scottish Performing Arts.


# **EXCHANGES OF ART**

Both the Dunedin Fine Art Center (DFAC) and the Stirling Smith Art Gallery & Museum have indicated an interest in creating an art exchange between the two institutions. While this exchange is still under development, in a meeting with DFAC senior staff, it was suggested they could provide a faculty exhibit, to "tell the story of Dunedin." This would be a mix of mediums: fiber, clay, painting, water color, etc. The Stirling Museum Director thought this was a great way to engage their local audiences with the sister city as she was not sure how many people in Stirling know about our relationship.

DFAC also suggested some sort of Artist Residency Exchange. While the Stirling Museum does not have funding for this, they would love to have someone from Dunedin take inspiration from their collections and Stirling to produce something.

This continues to be a work in progress, and will be updated as appropriate.

# Pen Pal Program

We envision a 21<sup>st</sup> century "pen pal" program, where students communicate via webcam/skype. We are working on getting a program for our middle school, and one high school program. This is still under development.

# Student Exchange Program

Proposed to Stirling (Stirling has thus far declined as of 3/2/20):

The City of Dunedin would host a Stirling student for three weeks (two weeks in Dunedin, Florida and one week in Glasgow, Scotland) at the end of July and beginning of August. The student would be a piper or drummer, at level Grade 2, between the ages of 15 and 18.

The student would spend two weeks in Dunedin at the end of July, living with a host family. They would take part in City band practices and possible performances, have private instruction from one of our band instructors, and would tour the Dunedin area sites. At the end of two weeks, they would travel back to Scotland with the Dunedin Pipe Band and spend a week with the band in Glasgow, with an opportunity to perform with our Grade 1 band in the World Championships.

We would like to send one of our students to Stirling for a similar program. The City of Dunedin (and local Scottish organizations) would raise the funds to send our student to Scotland. Stirling could similarly fund their student to come to Dunedin. We estimate the cost (of airfare and spending money) to be  $\sim$ \$3,000.



WHEREAS, the City of Dunedin is desirous of participating in the Peopleto-People program sponsored by the Amarican Kunicipal Association, and

WHEREAS, the City Commission of the City of Dunedin feels that affiliation with a Sister City in Scotland would be a desireble action, and

WHEREAS, after due deliberation, the City Commission has selected its proposed Sister City;

HOW, THEREFORE, be it resolved by the City Commission of the City of Dunedin in session duly and regularly assembled:

1. CITY OF TORONTO, ECONOMIC DEVELOPMENT & CULTURE DIVISION, hereinafter referred to as TORONTO ECONOMIC DEVELOPMENT, with headquarters in Toronto, Ontario, Canada, herein represented by its General Manager, Michael H. Williams and the CITY OF DUNEDIN, FLORIDA, hereinafter referred to as DUNEDIN, herein represented by its interim City Manager, Doug Hutchens, both represented in the form of their formation documents and hereinafter jointly referred to as the UNDERSIGNED;

# WHEREAS:

- The Mission of TORONTO ECONOMIC DEVELOPMENT is to grow Toronto's economy by assisting businesses and organizations wishing to establish or expand their ventures in the City of Toronto, generating jobs and income, as well as the continuous improvement of the competitiveness and image of the City.
- Among the activities of TORONTO ECONOMIC DEVELOPMENT are the provisions of support services for businesses wishing to expand in the city and for those who wish to establish in the city. These initiatives aim to improve the business environment in the City of Toronto.
- DUNEDIN wishes to develop and strengthen ties with international friendship cities, facilitate and coordinate exchanges and cooperation between Dunedin's foreign exchange activities.
- DUNEDIN is dedicated to promoting high-level visits between Dunedin and foreign cities and enhancing foreign exchanges and cooperation in trade and economy, science and technology, culture, education and athletics.



**APPENDIX F** 

• NOW THEREFORE, the Parties hereto agree to enter into this Memorandum of Understanding (MOU), in accordance with the following terms and conditions:

# **SECTION ONE – PURPOSE**

1.1 This Agreement aims to establish joint activities between the UNDERSIGNED, in mutual cooperation, within their legal and corporate duties, the promotion of activities of the UNDERSIGNED, in order to promote trade, attract new investment and grow the local economy, culture and athletics in the regions represented by the Parties.

# SECTION TWO - MUTUAL AGREEMENTS BETWEEN THE PARTIES

- 2.1 Without establishing any contractual or legal obligations (as is more fully specified in Section Three below), the UNDERSIGNED assume mutual agreements with one another, with due consideration for the objectives and goals of the other Party. These commitments include their best efforts to collaborate and cooperate mutually, as follows:
  - 2.1.1 Help identify industries and companies linked to their corresponding regions that may be interested in locating facilities or in doing business in the other Party's region.
  - 2.1.2 Encourage and support the interest of these industries by facilitating the sharing of education and information about the other region. Each Party will assist the other to share education and information, but will not undertake these activities on behalf of the other party.
  - 2.1.3 Direct companies interested in locating facilities or in doing business in the other Party's region to TORONTO ECONOMIC DEVELOPMENT or to DUNEDIN, as appropriate.
  - 2.1.4 Share current information and data on sustainable trends and development in each region and parties can explore areas of common interest including but not limited to culture, athletics, education, life sciences, financial services and information technology.
  - 2.1.5 Cooperate with the other Party in identifying certain businesses for their attention and development.



- 2.1.6 Cooperate with the other Party in assisting delegations from The City of Toronto and The City of Dunedin when they are visiting each other's region.
- 2.1.7 Share information relating to industries and companies with the other Party, complying with all applicable laws and all the confidentiality obligations that may exist.
- 2.1.8 Consider attending common receptions and events in the region of the other Party, in support of these objectives.

# SECTION THREE - OBLIGATIONS

- 3.1 As mentioned above, this MOU expresses the intentions of the UNDERSIGNED with regard to the subject matter herein. Each Party intends to exercise their best efforts to reach the objectives hereof. However, both Parties acknowledge and agree that no contractual or legal obligation shall be created by this MOU, and none of its sections may be invoked by either Party to demand obligations from the other. All projects and joint actions that may be entered into between the UNDERSIGNED will be subject to specific legal instruments, legally recognized as constituting obligations.
- 3.2 For any projects implemented by third parties pursuant to this MOU, each of the Parties shall require the applicants for any such projects to provide a full indemnification indemnifying the Parties hereto and their respective employees, agents and consultants, and saving them all harmless from and to all liability or damages in respect of any such projects undertaken and from the direct or indirect consequences thereof.

# **SECTION FIVE - VALIDITY**

- 5.1 This MOU shall only be valid for a TWO (2) year period commencing on the date of execution (signing) of this document unless one party notifies the other party, in writing, of the termination of this MOU within THREE (3) months prior to the respective renewal date.
- 5.2 This MOU may be renewed by mutual agreement in writing THREE (3) months prior the term of the TWO year period.



# SECTION SIX- MISCELLANEOUS

- 6.1. This MOU presents an agreement of cooperation between the UNDERSIGNED and may not represent any obligation, financing commitment or the commitment to enter into any specific transaction.
- 6.2 The Parties designate a person as the point of contact and hold dialogues on mutual exchanges and cooperation and issues of common interest.

IN WITNESS THEREOF, the Parties have caused this MOU to be duly executed in the English language with three copies of each being treated as equal.
