CALL TO ORDER: Chair Rob Cozen called the meeting to order at 10:00 am.

1. ADMINISTRATIVE

a. Rob Cozen requested the addition of Robert Groover and Jerry Shaffer, of The Veterans Alliance of Clearwater, be added to the New Business agenda

b. Approval of February 2024 Minutes

- **c.** Welcomes The committee welcomed the following members of the City of Dunedin Human Resources (HR) Department: Ms. Theresa Smalling (Director) and Ms. Alex Simpkins (Manager). The committee also recognized the presence of Vice Mayor Moe Freaney and Commissioner Jeff Gow.
- d. POW MIA Flag Ceremony Rob Cozen expressed his appreciation to the committee members for their efforts in garnering the City's approval to fly the POW MIA Flag under the U.S. Flag at City Hall. The Ceremony was held at City Hall on Tuesday, March 5, 2024.

e. City of Dunedin HR Department – The committee had requested information regarding any consideration veterans might receive with regards to the City's hiring practices. Ms. Smalling and Ms. Simpkins stated the city complies with State statues with regards to all hiring. Furthermore, there is a "Veterans Preference" instituted that requires a first round personal interview for any veteran applicant. There is also verbiage for disabled veterans and veteran spouses. All applicants (veteran and non-veteran) must meet the minimum positional qualifications. Approximately 10% of the City's employees are military veterans.

The committee was considering a table arranged in the City Hall lobby. After considerable discussion a motion was made to strike this item from our 2024 Plans of Action.

- c. Donald Roebling Park Larri Gerson provided a comprehensive information paper on the significance of Donald Roebling's Alligator amphibious tractor. The committee watched a video of the importance of these vehicles during WWII. Another YouTube video was identified that ties the Alligator directly to the region of Sterling Park. a. Veterans Alliance of Clearwater – Mr. Groover and Mr. Shaffer introduced themselves and described the Alliance hosting their 20th Anniversary Memorial Day

Celebration to be held at the new BayCare Sound and Coachman Park in Clearwater. This event will run from Friday, May 25 – Sunday, May 26 and include a parade, festival and concerts. There are an estimated 90,000 military veterans in Pinellas County. Rob Cozen asked Mr. Groover and Mr. Shaffer to continue to keep our committee updated on events and activities that might provide synergy with our efforts in the City of Dunedin.
