**106.07 Reports; certification and filing.—**

(1) Each campaign treasurer designated by a candidate or political committee pursuant to s. 106.021 shall file regular reports of all contributions received, and all expenditures made, by or on behalf of such candidate or political committee. **Except as provided in paragraphs (a) and (b), reports shall be filed on the 10th day following the end of each calendar month from the time the campaign treasurer is appointed, except that, if the 10th day following the end of a calendar month occurs on a Saturday, Sunday, or legal holiday, the report shall be filed on the next following day that is not a Saturday, Sunday, or legal holiday. .**

(b) Any other candidate or a political committee required to file reports with a filing officer other than the division must file reports on the **60th day immediately preceding the primary election, and biweekly on each Friday thereafter (i.e. 46th day, 32nd day, 25th day & 11th day) through and including the 4th day immediately preceding the general election.**

Covering October 1, 2022 – October 7, 2022

10/21/22 **G5-22 CTR 18th day immediately preceding the General Election**  
Covering October 8 – October 14, 2022

10/21/22 **Publication of Legal Notice of Election - 18 DAYS PRIOR TO ELECTION**  
F.S. 100.342 - - Once in the Third Week prior to the election

10/25/22 **Precinct poll watcher designations** for Election Day must be submitted to the City (**PRIOR TO NOON** on the second Tuesday preceding the election). The City will fax all poll watcher designations to the SOE at 464-6239, and the Supervisor will verify whether they are registered to vote in Pinellas County.

(City Code 26-36(d) **no more than 10 days prior to election**; and FS 101.20-at least 7 days prior to Election.)

Covering October 22 – November 3, 2022
