

RESOLUTION 22-12

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DUNEDIN, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE FOR AD VALOREM TAX REVENUE FOR FISCAL YEAR 2022-23 AT A RATE OF 4.1345 MILLS OR \$4.13 PER \$1,000.00 OF ASSESSED PROPERTY VALUE; PROVIDING FOR A SECOND AND FINAL PUBLIC HEARING DATE; AMENDING RESOLUTION 22-11 TO CHANGE THE PUBLIC MEETING START TIME FOR THE SECOND AND FINAL HEARING; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City is required to adopt the millage rate in accordance with the procedures set forth in section 200 065, Florida Statutes; and

WHEREAS, the City Commission established a maximum millage rate of 4.1345 mills or a millage rate of \$4.13 per \$1,000.00 of assessed property value for ad valorem tax revenue for the Fiscal Year 2022-23 on July 14, 2022; and

WHEREAS, in adopting Resolution 22-11, the City Commission originally set the date and time of the public meeting during which the second and final Public Hearing for the Fiscal Year 2022-23 Final Millage Rate and Final Operating and Capital Budget would be held in City Hall, City Commission Chambers as Thursday, September 29, 2022 at 6:00 p.m.; and

WHEREAS, the City Commission desires to change the start time of the public meeting to 5 00 p.m , with the second and final Public Hearing to begin immediately thereafter on September 29, 2022, and to amend Resolution 22-11 accordingly.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSIONERS OF THE CITY OF DUNEDIN, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, THAT:

SECTION 1. The above recitals are true, correct, and incorporated by reference as if set forth fully herein.

SECTION 2. The tentative millage rate for ad valorem taxes for the City of Dunedin, Florida for Fiscal Year 2023 is hereby set at 4.1345 mills


SECTION 3. The tentative millage rate of 4 1345 mills is 11.73% more than the FY 2022 "rolled back rate" of 3.7005 mills.

SECTION 4. Section 3 of Resolution 22-11 is hereby amended as follows:

"Section 3. The public meetings at which the Public Hearings on the Fiscal Year 2023 Budget and Millage Rate will be held are hereby established as Thursday, September 15, 2022 at 6 00 p.m and Thursday, September 29, 2022 at ~~6:00~~ 5:00 p m in City Hall, City Commission Chambers where interested parties may appear and address the City Commission on these issues "


SECTION 5. This Resolution shall become effective immediately upon its passage and adoption


