Summer Safety Tips

Please continue to be diligent during the summer months. Always feel free to contact us with any questions or concerns. We are here to help!

- Order **storm supplies** now while they are still available.
- Check your boat and **dock lines** frequently. Bungee style dock lines are not intended for long term or windy conditions. They abrade more rapidly than traditional dock lines and are not recommended.
- Keep **boat trailers** ready for use.
- Notify the marina office if you will be **out of town** for an extended period of time. Assign an alternate person to be responsible for securing your vessel and provide the Marina office with their contact information.
- Monitor all **email communications** from the Marina and the City of Dunedin, and add both to your safe sender list.
- Notify the Marina office if you change your **email address** so we can update our records.
- Always provide your required **insurance** declarations page upon renewal.
- **Disconnect your hose** while not in use to prevent it from becoming permanently fused to the hose bibb.
- **Shore power cords** must be unplugged from the pedestals when not in use.

Pram Shed Replacement Update

The Pram Shed is home to several sailing programs including the Windlasses and Dunedin Youth Sailing Association (DYSA). The storage facility had outlived its useful life and needed to be replaced. Demolition of the pram shed on the west side of the marina has been completed and construction of the new pram shed is underway. Please exercise caution when in the area of the construction zone.



Marina Reminders

For security reasons, the gate codes should not be shared with anyone in order to avoid the need to frequently change the codes. Any suspicious activity should be reported to law enforcement, making note of date and time for security camera review.

Periodic ramp usage is allowed for slip users needing to infrequently pull/launch their boat for storms, maintenance, vacation, etc. This courtesy is extended **only** for the vessel that is listed on the user agreement. For those using the ramp more frequently or for launching a vessel not on the user agreement, a ramp permit is required.
