## Office Matters

### Parking & Ramp Decals:

The current parking decals will expire on December 31st. The 2022 decals have been ordered and will go on sale in the office on December 1st, 2021, providing there is no unexpected delay from the printer.

### Extend Absences:

Please notify marina staff if your vessel will be out of the slip for more than a week. The extended absence form can be found on our website and emailed to the Harbormaster.

### Insurance Renewals:

Please be sure to provide the required copy of your annual insurance declarations page to the Harbormaster's office upon renewal.

## Happenings

**Piling Maintenance** - The piling replacement project has been completed.

**Plumbing Repairs** - Water lines along the west wall will be scheduled for replacement in November. Slip renters affected by temporary interruption of service while these improvements are underway, will receive notice prior to the start of the repairs.

## Reminders

### Commercial Charters:

Commercial activities are only permitted by vessels occupying slip numbers 4 through 12. Commercial chartering is not permitted by vessels occupying recreational slips, and may result in the cancellation of the user agreement.

**Trash Receptacles:** Cans provided throughout the marina are intended for small items. Boxes and full bags are to be taken to the dumpster provided in the northeast corner of the parking area.

**Shore Power Cords** should be disconnected from the pedestal and the breakers turned off when not in use. Cords should never be touching the water or crossing over finger docks.

**Check on vessels frequently**, including times of high winds, inclement weather, and when there are extreme high or low tides. Please make sure that anything of value is secured or removed when the vessel is not in use.

**Contact the Harbormaster** any time with any questions or concerns. Many answers can also be found in the Marina Rules & Regulations, which are available on our website.
