Taking the boat out for a while?

Please remember that any slip renter who plans on being out of the slip for over 72 hours (3 days) must notify the Marina staff of the slip's availability. In addition, if you plan to terminate your agreement, we must have that in writing as well indicating the exact date you plan to vacate your slip. For your convenience, forms for both Extended Leave and Slip Use Termination have been placed on the Marina website.

The Harbormaster's Office is now able to accept credit card payments for slip rental, parking decals, or boat ramp launch fees. Feel free to stop by to pay your monthly slip rental payments or you can visit Utility Billing located at 750 Milwaukee Avenue.

Please remember that you must have a current decal on your vehicle to park in the permitted spots. Parking decals are available for slip renters only (and are \$5.00 per vehicle. Due to limited availability, we cannot provide decals for other friends or family members. Please visit the Harbormaster's office to purchase your decal along with your vehicle information. Decals must be placed on the rear of the vehicle on the passenger side (window or bumper) and cars must be parked "nose in". Please note the Sheriff's office is currently enforcing the parking permit requirement and will issue citations.

Keep your Proof of Liability Insurance up to date

The City of Dunedin requires that all slip renters obtain a valid certificate of general liability insurance. A copy of the certificate must be submitted and kept on file at the Marina Office. When you are renewing your insurance policy, please be sure to forward a copy of your new certificate to the Harbormaster's Office.

Recreation slip renters must obtain a valid certificate of general liability insurance in the amount of \$100,000/\$300,000.

Commercial slip renters must obtain a valid certificate of general liability insurance in the amount of \$1,000,000 naming the City of Dunedin as an additional insured.

Projects Update

Sediment Removal and Dock A Repairs:

The surveys have been completed for the dredging of the Marina Basin and channel to the Intracoastal waterway. The consultant is currently applying for all necessary permits and finalizing cost estimates. To minimize the impact to the slip renters, the improvements to Dock A will be coordinated at the same time. Please stay tuned as more details with exact time frames and logistics are determined.
