## New Agreements, Rules & Regulations

The City of Dunedin has revised the Revocable Use Agreement for the Marina. As a result, **every slip renter** must complete and sign a new agreement. Renters have three options to complete this process:


- 1. Visit the Marina page on the City website. Complete the agreement, print, sign and deliver to the Harbormaster.
- 2. Contact the Harbormaster and have an agreement with the information from your original agreement emailed to you. You can then update the agreement with your current

- information, print, sign and deliver to the Harbormaster.
- 3. Schedule a time to visit the Harbormaster in person. A new agreement will be prepared for your signature.

Whichever option you choose, please visit the Marina page on the City website for complete instructions.

Lastly, the Marina Rules and Regulations have been updated as well. We ask each slip renter to also complete an Acknowledgement Form (available at the Marina office or on the website).

## Liability Insurance - New Information



The City of Dunedin requires that all slip renters obtain a valid certificate of general liability insurance. A copy of the certificate must be submitted and kept on file at the Marina Office. If you are renewing your insurance policy, please be sure to forward a copy of your new certificate to the Harbormaster's Office.

**Recreation slip renters** must obtain a valid certificate of general liability insurance in the amount of \$100,000/\$300,000.

Commercial slip renters must obtain a valid certificate of general liability insurance in the amount of \$1,000,000 naming the City of Dunedin as an additional insured.

### **Projects**



**Fishing Pier:** the refurbishment project is estimated to be completed by December with new composite decking, a widened walkway, new railings and benches.

**Clearwater Ferry:** The pilot program is currently on hold while logistical details are explored.

**Sediment Removal:** The survey consultant has been hired and will give planning and design recommendations for work in 2019.

## Parking Decals



In previous years, parking decals were automatically billed to your account. This created problems for many who pay their slip rents with auto-pay and then incurred late charges. To alleviate this we have eliminated the automatic charge. On your next visit to the Marina, please see the Harbormaster in person to obtain your 2018 decal. Please remember to bring in a copy of the vehicle registration for each car you need a decal. Decals are \$5.00 per vehicle.
