A portion of Lot 11, Weathersfield, as recorded in Plat Book 99, Pages 53-58, of the Public Records of Pinellas County, Florida and being more particularly described as follows:

Commence at the most northwesterly corner of said Lot 11 and run southerly along the westerly lot line of Lot 11 South $00^{\circ}-02'-44"$ Ease, 72.87 feet to the POINT OF BEGINNING; Thence South $45^{\circ}-17'-15"$ East, 45.63 feet to a point on the south line said Lot 11; Thence along the south line of Lot 11 along a curve to the right with a radius of 25.00 feet, length of 30.77 feet, chord of 28.87 feet and chord bearing of North $54^{\circ}-46'-52"$ West; Thence along a curve to the left with a radius of 50.00 feet, length of 17.90 feet, chord of 17.80 feet and chord bearing of North $29^{\circ}-46'-15"$ West to the POINT OF BEGINNING.
