## Marina Maintenance

## Marina Dredging Update

We are excited to report that the bidding process has begun for the marina dredging project. The bids will be opened and reviewed during the week of February 17th. Once the project is awarded to a contractor, we will be able to share more detailed information with our slip renters as it becomes available including start dates and duration of the project. We continue to be hopeful that we will have a start date sometime this summer with completion by October.

Dunedin Marina will be inaccessible during the project including the boat ramp. At this time, we would like to ask vessel owners to begin considering alternate plans for storing their vessels while the dredging is underway. With fewer vessels in the marina basin, the project will be able to proceed in a more timely manner. Although it is not mandatory, we would like to strongly suggest that you remove your vessel from the marina if you have a trailer and are able to. Owners may even want to consider scheduling vessel maintenance at that time.

Slip rent will be waived during the period of time that our marina is inaccessible. Once we have a start date, we will inquire with other local marinas to check for slip availability and provide that information our customers. Slip renters will be responsible, however for making arrangements and payments directly with those marinas.

Vessels remaining in the Dunedin Marina must be moved when it is time to dredge the area around the occupied slip. The owner will be given sufficient notice to move the vessel to another area within the marina. If an owner cannot be reached or is not available, it will be necessary for marina staff to move these vessels.

We will be asking all of our slip renters to please send us an email confirming what plans have been made for your vessel as we get closer to the start date. It will be very important for us to have that information in order to coordinate the movement of the vessels that remain in the slips.

Our main form of communication with slip renters regarding the dredge will be email. Please be sure to read all email correspondence carefully for important details as they become available. If you have any questions, feel free to contact us at any time.
