4.a. **Review the Ordinance Review Committee 2018 Report and Recommendations**

The 2018 Report,

Shannon Smith advised the City Charter, Article VI. - General Provisions, Section 6.03. - Ordinance Review states:

At least once every five (5) years, the City Commission shall appoint a committee from the City electors to review the City ordinances.

Mr. Smith inquired as to why the Ordinance Review Committee was not reviewing the Land Development Code (LDC) in addition to the Code of Ordinances. He was advised by the City Attorney that the City Commission wanted the ORC to focus on the Code of Ordinances, not the LDC. The City Attorney also advised Mr. Smith that the Commission could request the current ORC to complete the review of the LDC, establish a new committee to review the LDC or decide to do it at a later date.

ORC Recommendation. Charter Section 6.03 requires that "At least once every five (5) years, the City Commission shall appoint a committee from the City electors to review the City ordinances." The ORC would recommend that the City Commission authorize a review of the LDC as required by the Charter.
